AWARD NOTIFICATIONS ISSUED FOR GILMAN PROGRAM March 2022 Deadline

May 4, 2022 – The U.S. Department of State’s [Benjamin A. Gilman International Scholarship Program](#) is pleased to announce that nearly 3,000 U.S. undergraduate students have been selected to receive Gilman Program awards from the March 2022 application deadline. Despite the ongoing pandemic, as travel and study abroad have opened, we are pleased to announce a higher selection number this award cycle. The recipients of this prestigious scholarship are American undergraduate students attending 536 U.S. colleges and represent 49 U.S. states, the District of Columbia and Puerto Rico. These Gilman Scholars will study or intern in 91 countries through April 2023. This group includes 20 recipients of the John McCain International Scholarship for the Children of Military Families (Gilman-McCain Scholarship), as well as Gilman Scholars supported by the governments of France, Israel, New Zealand, and Wales, and the Luso-American Development Foundation (FLAD) in Portugal, the Taipei Economic and Cultural Representative Office in the United States (TECRO), and the German Academic Exchange Service (DAAD). Given the disruption of the pandemic, the Gilman Program is committed to offering flexibility to participants whose plans may be impacted. The Gilman Program will support students who are unable to start their programs abroad in their original destination or in the original timeframe by permitting students to defer to a program starting later or by supporting participation in a virtual study abroad or international internship program.

The U.S. Department of State’s Bureau of Educational and Cultural Affairs (ECA) recognizes all the American students who applied for the March 2022 deadline, as well as the nearly 200 selection panelists from colleges and universities across the nation who reviewed their applications. We appreciate all the educators who continue to promote the Gilman Program and support their students in education abroad and international exchange experiences.

Gilman Scholars receive up to \$5,000, or up to \$8,000 if also a recipient of the Gilman Critical Need Language Award, to apply toward their study abroad or internship program costs. Since the program’s inception in 2001, more than 34,000 Gilman Scholars from all U.S. states,

the District of Columbia, Puerto Rico, and other U.S. territories have studied or interned in more than 155 countries around the globe. The program has successfully broadened U.S. participation in study abroad, while emphasizing countries and regions where fewer Americans traditionally study. As Secretary of State Antony Blinken said, “People-to-people exchanges bring our world closer together and convey the best of America to the world, especially to its young people.”

The late Congressman Gilman, for whom the scholarship is named, served in the House of Representatives for 30 years and chaired the House Foreign Relations Committee. When honored with the Secretary of State’s Distinguished Service Medal in 2002, he said, “Living and learning in a vastly different environment of another nation not only exposes our students to alternate views but adds an enriching social and cultural experience. It also provides our students with the opportunity to return home with a deeper understanding of their place in the world, encouraging them to be a contributor, rather than a spectator in the international community.”

The Gilman Program is sponsored by the U.S. Department of State’s Bureau of Educational and Cultural Affairs (ECA) and is supported in its implementation by the Institute of International Education (IIE).
